WHEN A CHILD IS DETERMINED TO BE AT RISK IN THEIR CAREGIVERS HOME, WE PROVIDE FOSTER CARE PLACEMENT AND ADOPTION SERVICES AND WE RECRUIT AND TRAIN FOSTER PARENTS THAT CAN PROVIDE THE CARE YOUTH NEED.
